Please be informed that we are in receipt today a copy of the Decision dated August 5, 2011 relative to the case docketed as "Ramon S. Matias, doing business under the name and style of Chino's Machine Shop & Equipment Rental, Plaintiff vs. Semirara Coal Corporation/Semirara Mining Corporation, Defendants, Civil Case No. 70015, Regional Trial Court Branch 71, Pasig City." The case refers to a collection of sum of money and damages to which the court rendered judgment in favor of the Plaintiff. The decretal portion of the Decision reads, as follows:
